Stephanie: need a sign at the front door. Russ: it's not just the hot water, it's the ability to plug in anything else, anything we put up that's electrical. fuse gets blown. Jason: it's about adding a circuit. Tim: tyring to clarify. i'm a general contractor. Mike: need licensed. Tim: i'll let you know. Russ: check it out but to understand what it is we are trying to accomplish. let's do that offline.

Mike: tim is going to look at it. if he can't, can i get a motion to up the bid
to 1600 and then we can get this one and over with?
Russ: up the bid to \$1700.

OLD BUSINESS

Carla: yes, i can.

Steph: want to understand scripts better. seems like the script is different for each mtg. don't want it to be the same script as weds newcomer mtg. dong same scripts?

Russ: no, not the same. gone over this that ea mtg can make changes to their script and there are guidelines to the script. 15 mtgs used identical script. i'd like to throw out for discussion, i'l like to see secretaries make these announcements: potlucks, etc. the rec comm would supply that to secty and secty will make announcements. it creates a process for someone to make announcement so it's aa related. have a tab in book "announcements" and

secty would read from there.

Jervice: if that doesn't work, i've seen mtgs have a clipboard and pass it around and people who want to look at fliers look at them. Mike: table rec comm announcements procedure for next month.

BYLAWS

Bonnie: mike, phyllis and I worked on bylaws. they were a mess with formatting, moved stuff around, cleaned up grammar. ended up with mtgs on content changes. Mike: i'm proposing to put up the bylaws on the back bullitain board and then come back and vote on it. you guys take a look at it and we'll vote on it next month. not changes the law or rules, only grammar and format. How many secretaries are here? only one. Russ: need a process for announcements. i'll email secretaries that bylaws are on board.

Mike: i'll send them to eric to put them online. i'll do that tmrw.

NEW BUSINESS

Jervice: situation with new pet, the cat. last year PHG voted only service animals allowed. cat comes in. some have severe allergies. Russ: kick the cat's ass out. Mike: have it on table to stop providing food for the cat. Jason: call animal control. Tim: if you feed it, it'll come back. the owners live across the stret. there's a sign that says no dogs with the cat has full reign. Russ: full reign is heavy handed. it just shouldn't be allowed int he room. Carla: by feeding the cat, we are feeding the rats. Jervice: i agree with the free reign. cat comes in by itself. open door and it's accostomed to coming in. people wouldn't open door because would come in. it's going to take some retraining.

Russ: if we 86 the cat, then the feeding has to stop. landlord knows the owners.

Tim: someone needs to talk to the landlord. Mike: the landlord loves that cat. if you feed it'll come. if not fed, it'll stop coming. the cat has a chip. we don't feed it, don't let it in. it isn't fair to people who have allergies and no dogs allowed. Karin: seems prudent, if the landlord knows owner, have landlord tell owner to keep the cat inside for a while. just having the owner take responsibility and create a humane way of dealing with the issue. Jason: know this group, that's not going to work: don't feed the cat. the secretaries won't spread the word. what she said is correct: need responsible party to take responsibility. Mike: if you call animal control, they'll just call the owner. Steph: is it possible that secretaries can make announcements, short one, please dont let cat in or feed the cat. the cat can't come in. needs to be communicated. for safety of humans and cat. Jervice: i think announcement should be on the door that service animals allowed. be consistent. i heard that landlord said only service animals. Bonnie: put sign on the door. Mike: before we leave today, i'll make a sign on the door and put in binder to secretaries: don't feed the cat.
